1. <u>Situation</u>. The 3d Marine Division Noncommissioned Officer (NCO) and Marine of the Quarter and Year Program serve an important command function by acknowledging our most outstanding Marines.

- 2. Cancellation. DivO 1651.1.
- 3. Mission. To recognize our finest NCOs and Marines.
- 4. Execution
  - a. <u>Commander's Intent and Concept of Operations</u>

(1) <u>Commander's Intent</u>. This program is designed to recognize those Marines who have made significant contributions to the Division throughout the calendar year. The emphasis is on the specific acts, accomplishments, and sustained performance that distinguishes them from their peers.

DISTRIBUTION STATEMENT: Approved for public release; distribution is unlimited.

#### (2) Concept of Operations

(a) All Major Subordinate Elements (MSE) are eligible to submit NCO and Marine of the Quarter and Year nomination packages in accordance with this order.

(b) Each MSE will be allowed to submit one nomination per category per quarter.

(c) At the end of the Calendar Year (CY), each NCO and Marine of the Quarter from the previous CY quarters will compete for NCO and Marine of the Year, if still assigned to 3d Marine Division.

(d) In determining if a Marine is "exceptionally qualified," particular attention will be given to the "whole Marine" concept. The performance of the Marine during the specific quarter or calendar year, both on and off duty, is to be considered.

(e) Commanders must consider the following when screening nominees for NCO and Marine of the Quarter:

<u>1</u>. Must have received permanent change of station (PCS) or permanent change of assignment (PCA) orders for assignment to 3d Marine Division or one of the MSEs and have served in 3d Marine Division for the entire quarter for which considered.

<u>2</u>. Cannot be a prior 3d Marine Division NCO or Marine of the Quarter.

3. Meet the Marine Corps height, weight, and body composition standards.

 $\underline{4}$ . Completed appropriate in grade Professional Military Education requirements per ref (b).

5. Have met all training requirements within the last 12 months, or be officially exempt from specific requirements, per ref (c).

<u>6</u>. Must have scored a first class on their most recent Marine Corps Physical Fitness Test and Combat Fitness Test.

 $\underline{7}$ . Have average proficiency/conduct (pro/con) markings in grade of 4.5/4.5, for corporals and below.

 $\underline{8}$ . Received no derogatory page 11s (6105s), non-judicial punishment, or courtsmartial within the past 12 months.

9. Active in the Marine Corps' professional reading program per ref (d).

(e) Members of the Division Board must consider the following when screening nominees for NCO and Marine of the Year, in addition to all requirements in paragraph 4.a.(2)(e):

<u>1</u>. Sergeants with more than six months time in grade at the time the NCO of the Year Board convenes must have completed Regional, Culture, and Language Familiarization (RCLF) Program Enlisted Block 3 per ref (e). This completion must be annotated on the Marine's Basic Individual Record.

 $\underline{2}$ . Have qualified with the service rifle during the previous fiscal year (FY), or have an official exemption or waiver approved, and reflected on their Basic Training Record, per ref (f).

<u>3</u>. Have passed the Battle Skills Test during the CY for which they are being considered, per ref (g).

<u>4</u>. Have satisfied the minimum requirements by reading five books off of the Commandants Professional Reading Program List during the CY for which they are being considered, per ref (d).

5. If competing as a Corporal for Marine of the Year, must have been promoted within 90 days of the Division Board convening.

#### b. <u>Tasks</u>

# (1) <u>MSE Commanders</u>

(a) Nominate Marines for consideration as Division NCO or Marine of the Quarter. The packages will be submitted electronically to the Division Staff Secretary (SSEC) Chief by 1600 on the date required by the published Division Bulletin announcing the board.

(b) Provide a Sergeant Major and a Master Gunnery Sergeant as board members.

(c) For all NCO and Marine of the Quarter winners, continue to collect data on their performance and contributions for the remainder of the CY, in order to add additional information to their "of the Year" write-ups and packages.

#### (2) Division Sergeant Major

(a) Conduct a board during the month immediately following each CY quarter to select the Division NCO and Marine of the Quarter, and during January of each calendar year to select the Division NCO and Marine of the Year. Coordinate with the MSEs for date, time, and location.

(b) Announce the winners of each board once approved by the Commanding General. The NCO and Marine of each Quarter will receive:

 $\underline{1}$ . Certificate of Commendation from the Commanding General, and a certificate signed by the Commanding General and Division Sergeant Major

 $\underline{2}$ . A 72 hour special liberty, to be taken at the discretion of the Marine's chain of command based on operational commitments.

(c) The NCO and Marine of the Year will receive:

<u>1</u>. Navy and Marine Corps Achievement Medal, awarded by the Division Commanding General. If the NCO and/or Marine of the Year are selected as the III Marine Expeditionary Force NCO or Marine of the Year, the Navy and Marine Corps Achievement Medal will be awarded by the Commanding General, III Marine Expeditionary Force.

 $\underline{2}$ . A 96 hour special liberty, to be taken at the discretion of the Marine's chain of command based on operational commitments.

<u>3</u>. The NCO of the Year will accompany the Commanding General and Sergeant Major to the Marine Corps Association and Foundation Ground Awards Dinner in the spring of the year to be recognized by the Commandant of the Marine Corps, per ref (h).

#### (3) <u>Staff Secretary Chief</u>

(a) Collect all packages from the MSE S-1s by the due date.

(b) Provide hard copies of all packages to the Division Sergeant Major for the Board.

(c) Produce data sheets and voting sheets for each member of the Board.

(d) Ensure that digital copies of each photo are received in JPG format, and display them on the monitors in the Commanding General's Conference Room during the Board.

(e) Prepare Certificates of Commendation and NCO and Marine of the Quarter certificates per paragraph  $4.b.(2)(b)\underline{1}$ . of this order, and Navy and Marine Corps Achievement Medals per paragraph  $4.b.(2)(c)\underline{1}$ . of this order.

#### 5. Administration and Logistics

a. At a minimum, the nomination packages will contain the following items:

(1) Battalion Commanding Officer's nomination letter, enclosure (1).

(2) Regimental Commander's endorsement and recommendation, if applicable.

(3) Board record data sheet, enclosure (2).

(4) Electronic promotion style photograph in the service "C" uniform, enclosure (3).

(5) One page biography, enclosure (4).

(6) Nominee's basic individual record (TBIR), basic training record (TBTR), education (TEDU), record of service (TROS), awards (AWDS), legal (D119), and chronological (CHRO) screens from the Marine Corps Total Force System (MCTFS).

(7) All NAVMC 118 (page 11) from the OMPF.

(8) All Unit Punishment Books from the OMPF (if applicable).

(9) Master Brief Sheet for all Sergeants.



# Sergeant John M. Smith Rifle Squad Leader 1st Battalion, 3d Marines

Sergeant Smith was born on 10 November 1995 in Raritan, New Jersey. He enlisted in the United States Marine Corps and reported to Recruit Training at Marine Corps Recruit Depot Parris Island, South Carolina, in June of 2014. Upon graduation from Company K, 3d Recruit Training Battalion, he was meritoriously promoted to Private First Class for graduating as the Company Honor Man. He then reported to Infantry Training Battalion, School of Infantry (East), Camp Geiger, North Carolina, and earned the military occupational specialty of 0311, Rifleman, upon graduation. He was also meritoriously promoted to Lance Corporal for graduating as the Company Honor Man.

In December of 2014, Lance Corporal Smith reported to 1st Battalion, 6th Marines at Camp Lejeune, North Carolina. While assigned to Company A, he served as a Rifleman and Automatic Rifleman. From July to December of 2015, he served as a Team Leader while the Battalion was deployed with the 22d Marine Expeditionary Unit to the Mediterranean. In December of 2015, he was meritoriously promoted to Corporal.

Corporal Smith graduated from Corporals Leadership Course as the recipient of the Iron Man and Gung Ho Awards, and attended Advanced Infantry Marine Course, where he graduated as a Distinguished Graduate. From January to June of 2017, he deployed with the Battalion on the Unit Deployment Program to Okinawa, Japan, as a Squad Leader. He was awarded the Navy and Marine Corps Achievement Medal following deployment.

In January of 2018, he was promoted to his current rank, and attended Infantry Small Unit Leaders Course, where he was the Honor Graduate. Sergeant Smith then attended Sergeants Course, where he was the recipient of the Gung Ho Award and was named a Distinguished Graduate. Upon reenlistment, he received orders to 1st Battalion, 3d Marines at Kaneohe Bay, Hawaii, and was accepted for the Squad Leader Development Program, earning the military occupational specialty of 0365.

Sergeant Smith reported to 1st Battalion, 3d Marines in June of 2018. From December of 2018 to May of 2019, he deployed with the Battalion on the Unit Deployment Program to Okinawa, Japan, as Squad Leader. Sergeant Smith currently serves as a Squad Leader with Company C, and as the Battalion Color Sergeant.

Sergeant Smith is married to the former Rena Johnson of Raritan, New Jersey, and they have two sons, Dan and Smedley.
